Minutes of the of Meeting of Swine Parish Council held on 18<sup>th</sup> November 2021  
at St Mary's Church Vestry, Swine

**11/2021/01 – Attendees:** Cllrs Y Wilkinson, E McMullen, D Oliver, G Bloom, and J Mackereth .

**11/2021/02 – Apologies:** Cllrs A Thompson and A Hunter

**11/2021/03 – Approval of minutes:**

Minutes of the meeting held on 12<sup>th</sup> August 2021 were read and approved.

**11/2021/04 – Police Reports:**

These had been previously circulated to Councillors in advance of the meeting. No comments were raised.

**11/2021/05 – Clerk's Report:**

- (A) Clerk updated Councillors on the enquiry regarding the horse chestnut tree on Coniston Lane. An email has been received from East Riding of Yorkshire Council confirming that the tree falls within the Conservation Area and therefore any work to the tree would require approval.
- (B) Clerk advised of amendments to the Electoral Register (0 alterations to the Open Register, 1 deletion from the Full Register).

**11/2021/06 – Finance:**

- (A) Clerk confirmed the balance at the bank as of 15<sup>th</sup> October 2021 to be £2,152.40.
- (B) Clerk informed Councillors that a renewal notice had been received from Zurich Insurance, with renewal being due on 1<sup>st</sup> January 2022. Following consideration of the situation last year regarding alternative quotes Councillors agreed to the renewal at an unchanged cost of £224.00.
- (C) Clerk sought approval from Councillors for the purchase of the usual Remembrance Day wreath from the Royal British Legion at an unchanged cost of £22.50. A cheque will need to be drawn for a total of £67.50 to cover the cost of 3 wreaths; the 2019 cheque was never cashed and the Parish Council was never invoiced for 2020.

**11/2021/07 – Withernwick Wind Farm Community Fund Grant:**

Councillors had previously discussed spending the grant of £1,000.00 on repair and maintenance to the War Memorial in the church yard. A vote was taken as to approval of the expenditure of £968.40 in line with a quotation from W. P. Everingham & Sons Ltd which was passed 5-0. Councillors requested that as Coniston also have soldiers listed on the memorial

the Clerk write to Coniston Parish Council asking whether they would be prepared to contribute to the ongoing upkeep of the memorial.

**11/2021/08 – Consideration of planning application 21/00924/STPLP (Castle Hill Flood Alleviation Scheme):**

Councillors had previously had sight of the planning application and raised no comments or objections.

**11/2021/09 – Consideration of email regarding the Queen's Platinum Jubilee Beacons:**

Councillors decided that this was not something the Parish Council wished to take part in.

**11/2021/10 – Consideration of email from Newbald Parish Council regarding Parish Councils' relationship with East Riding of Yorkshire Council:**

Councillors agreed with the proposals made by Newbald Parish Council and that they agree to join in any correspondence in this regard submitted by them to East Riding of Yorkshire Council.

**11/2021/11 – East Riding of Yorkshire Council's Annual Rough Sleepers Survey:**

Councillors agreed to delegate responsibility for submission of a zero return to the Clerk.
