Minutes of the of Swine Parish Meeting held on 16<sup>th</sup> August 2022

**08/2022/01 – Attendees:** Cllrs Y Wilkinson, E McMullen, D Oliver, A Thompson and G Bloom

No members of the public were in attendance

**08/2022/02 – Apologies:** Cllrs J Mackereth and A Hunter

**08/2022/03 – Approval of minutes:**

Minutes of the meeting held on 10<sup>th</sup> May 2022 were read and approved with a slight amendment to remove mention of the meeting being held “remotely via Zoom”. New copies to be prepared and signed by Cllr Wilkinson.

**08/2022/04 – Police Reports:**

Crime reports received since the last meeting had been circulated to Councillors on email or hard copy prior to the meeting. Councillors offered no comments on these.

**08/2022/05 – Clerk’s Report:**

Clerk had nothing to report.

**08/2022/06 – Finance:**

- (A) Bank balance was confirmed to be £1,365.90 as of 15<sup>th</sup> July
- (B) The request for the expenditure of £55 in respect of renewal of the Clerk’s membership to Society of Local Council Clerks was considered and approved.
- (C) Consideration was given to payment of the Clerk’s expenses. A sum of £200 was suggested by Cllr Wilkinson and approved unanimously.
- (D) A minor amendment to the cheque previously drawn in favour of East Riding of Yorkshire Council was initialled ready for re-submission for payment.

**08/2022/07 – Humber Talking Survey:**

Councillors considered the Survey and indicated that their major areas of concern were general rubbish/litter, fly-tipping and off-road motorcycles. They indicated level 3 (out of 5) for confidence that police would be there if needed, and that there was no-one living nearby who may need support.

**08/2022/08 – Proposed Solar Farm at Turf Carr:**

Clerk updated Councillors that the proposed developers had offered an assurance that access to the proposed Solar Farm would not be via Swine village.

**08/2022/09 – Date of next meeting:**

Next meeting was set for Tuesday 15<sup>th</sup> November 2022 at 7pm in St Mary's Church Vestry.

**Any other business:**

Clerk was requested to chase up the issue of stones on the grass verge at East/West View and other issues raised at the last meeting. Also, the "Give Way" sign at the T-junction by the disused railway/cycle track is not clearly visible. Councillors also asked the Clerk to clarify the grass cutting schedule for the Parish.

Cllr Thompson provided an update following his attendance at the meeting regarding the East Riding Stages Rally. The Rally is proposed to take place on 25/26<sup>th</sup> February 2023, but is not intending to pass through Swine village as part of one of the stages, only as a transition from one stage to the next. It will end at the 30mph sign at the Kelwell side of the village. Access to the village will be maintained. Cllr Thompson indicated that money is available to help with local village causes. It was noted that the clock on the Church tower is badly in need of repair and it was suggested that perhaps the Church Council could be made aware of the possible funds being available. Cllr Thompson will provide details of the relevant contact at the rally organisers in order that the Clerk can write to the Secretary to the Church Council (Pat Porter) suggesting application be made for financial assistance for clock repairs.
